EFM Industry Sessions will be hybrid in 2022, with its on-site focus extended by additional online programmes and features.

Vibrant ideas and risk-taking entrepreneurs are more important now than ever before. With the tumultuous changes of the past year, innovation is at the core of the industry's survival and growth.

We invite you to submit your proposal and materials by January 7, 2022 for an opportunity to take part in this exciting media/ technology showcase.

WHAT TO EXPECT

As one of the companies selected to participate in EFM Startups 2022 we offer you the opportunity to liaise with successful media companies who have been hand-picked to hear about and experience your innovative ideas for the film industry be it in story-telling and development, production, distribution or marketing. If selected, you will:

- 1. Be invited to pitch your Startup to an invited audience of producers, financiers, distributors and marketing professionals.
- 2. Represent your Startup at 1:1 meetings, both on-site and online, with hand-picked top industry professionals.
- 3. Take part in the European Film Market with a pop-up office at the EFM headquarters and market hub in the Gropius Bau.
- 4. Take part in two customised trainings prior to the EFM including a pitch training and a workshop on Startup financing.
- 5. Receive a Market Badge to the EFM for **two** company members which will allow access to all things EFM, including seminars, workshops, discussions and events, as well as selected market screenings.
- 6. Have access to the full EFM website, which includes contact details for all EFM participants (e.g. registered producers, exhibitors, distributors).
- 7. Online presentation as a participating Startup via a Company Profile Page on the EFM website.
- 8. Attend selected social events presented by the EFM.

CRITERIA

To qualify for selection, you/your company should:

- 1. Be a unique, innovative Startup which intersects with the media/audio-visual industry.
- 2. Have an interdisciplinary team.
- 3. Be at least in the Early Stage with an MVP (but can be further along as well).
- 4. Have an English language website.
- 5. Be prepared to present your Startup in English.
