WHAT TO EXPECT

If you are selected as an EFM Startup, we offer you the opportunity to pitch your Startup idea on-stage to industry professionals and to liaise with successful media companies who have been hand-picked to hear about and experience your creative ideas for the film industry.

- 1. Pitch your Startup onstage to an audience of accredited producers, distributors and marketing professionals.
- 2. Take part in a series of 1:1 meetings with top industry professionals registered at the EFM.
- 3. Take part in structured meetings with investors to learn about opportunities in the sector.
- 4. Receive complimentary EFM accreditation for **two** company members which will allow access to all things EFM, including seminars, workshops, discussions and events, as well as selected market screenings.
- 5. Be present in the European Film Market with a POP-UP Office at the EFM headquarters and market hub in the Gropius Bau.
- 6. Take part in customised trainings online with industry experts prior to the EFM.
- 7. Have your company profile on the EFM website.
- 8. Have access to the full EFM website, which includes valuable information / contact details for all EFM participants (e.g. registered producers, exhibitors, distributors).
- 9. Potential to take part in activities with Berlinale Talents and the Berlinale Co-Production Market.

- 5. Be prepared to present your Startup in English
- 6. Be available for all trainings prior to the EFM
- 7. Founders or C-Level executives must be available to attend the 4 Startup days in Berlin
